### DISCLAIMER STATEMENT

With my signature I confirm my registration for the Enduro Tirol Mountain Bike Event mentioned above. I am expressly aware that the StVO applies on the entire route and that the instructions of the police, the track personnel and the fire brigade must be followed. By signing, I confirm that I have read and understood the disclaimer and hereby give my legally binding consent to it. I have filled out the registration form truthfully and completely.

### DISCLAIMER

All participants take part in the event at their own risk. They shall bear sole civil and criminal liability for any damage caused by them or their sports equipment. Participants waive any right of action or recourse against all those involved in the organization of the event by submitting the notification for any accident or damage suffered in connection with the event, in particular:

- the above-mentioned organizer, its representatives and assistants,
- the owner (s) of the land used for the event and of the buildings and facilities, against the operator of the route used for the event and his or her agents and assistants; and
- ITS GmbH.

This Agreement shall become effective for all parties upon submission of the application to Racement (subject to changes to this tender) and shall be reconfirmed with this form. Each participant expressly confirms that the information entered on the registration form is completely correct. It is expressly pointed out once again that mountain biking involves health risks and an increased risk of accident/injury. During the transfer stages, participants are normal road users. In public transport areas, the StVO applies in full. All legal issues of the Enduro Tirol series are governed by Austrian law.

Against

- the other participants (applicants, drivers), their assistants, the owners of the other vehicles
- your own applicant, your own driver (s) (other special agreements between applicants and drivers take precedence!) and your own assistants

they waive claims of any kind for damages arising in connection with the competition or training (warm-up, prologue, race, running, qualifying examination), except for damages resulting from injury to life, limb or health resulting from a willful or negligent breach of duty – including those of a legal representative or vicarious agent of the disenfranchised Circle of persons – are based, and except for other damages, which are based on an intentional or grossly negligent breach of duty – also on the part of a legal representative or vicarious agent of the disqualified circle of persons.

The disclaimer becomes effective with respect to all participants when the online registration is sent to Racement, the series organizer ITS GmbH or the aforementioned organizer. The waiver of liability applies to claims for any legal reason, in particular to claims for damages arising from contractual as well as non-contractual liability and also to claims arising from tort. Implied disclaimers remain unaffected by the foregoing disclaimer.

Participants agree to the general data protection declaration of Enduro Tirol events (see www.enduro.tirol).

Mountain biking is dangerous. Events are insured by organisers' liability insurance.
